MANAGE SUCCESS STORY

In 2023, a large produce farmer sought assistance to assess whether his operation could remain viable. He was unsure of his break-even point and whether he could continue paying employees. Over the course of 2023 and 2024, break-even prices for each product were calculated, allowing for decisions on which items to purchase wholesale and which to continue producing. A sales strategy was also implemented to maintain payroll as long as key targets were met. With improvements in efficiency, sales, and cost management, the operation is now stable and poised for long-term success.




The Dairy Gauge Program is a joint effort between UT Dairy and the MANAGE Program. This financial program is focused on one-on-one support between consultants and dairy farmers to help understand cost of production, identify areas of financial strength, and opportunities to gain efficiency.

19 farms Participated in Tennessee and Kentucky

13 participating farms in Tennessee represented **60%** of the state's milk production

The 19 farms reported a gross income of **\$86 million** and incurred **\$75 million** in expenses, contributing significantly to the local economy.



INCOME TAX SEMINARS

Each year the University of Tennessee Extension, in cooperation with the Internal Revenue Service and Tennessee Farm Bureau, sponsor tax seminars at various locations throughout Tennessee. The instruction is directed toward tax professionals who prepare and file tax returns for farm and non-farm businesses and individuals.
